Notes on Contributors

ROBERTO BREÑA has a PhD in the history of political thought from the Universidad Complutense in Madrid, Spain. He is a professor and researcher at the Centre for International Studies of El Colegio de México in Mexico City. His main academic interests regard the history of liberalism, liberalism in the Spanish-speaking world during the Age of Revolutions, the Atlantic Revolutions, intellectual history, and contemporary historiography. He is the author or editor of four books on the first Spanish liberalism and the Spanish American independence movements. Among his relatively recent publications are "Tensions and Challenges of Intellectual History in Contemporary Latin America," Contributions to the History of Concepts, vol. 16, issue 1, 2021, and the anthology Las revoluciones hispánicas y la historiografía contemporánea (2021).

NICHOLAS BUCCOLA is the award-winning author of *The Fire Is* Upon Us: James Baldwin, William F. Buckley Jr., and the Debate over Race in America (2019) and The Political Thought of Frederick Douglass: In Pursuit of American Liberty (2012). He is also the editor of The Essential Douglass: Selected Writings and Speeches (2016) and Abraham Lincoln and Liberal Democracy (2016). His next book, One Man's Freedom: Goldwater, King, and the Struggle over an American Ideal, will be published by Princeton University Press in 2025. He is co-editor, with Susan McWilliams Barndt and Roosevelt Montás, of The Princeton History of American Political Thought, which will be published in 2026. His essays have been published in scholarly journals, including The Review of Politics and American Political Thought, as well as popular outlets such as The New York Times, Salon, and Dissent. He is the Dr. Jules L. Whitehill Professor of Humanism and Ethics at Claremont McKenna College.

ALEJANDRO CASTRILLON is an assistant professor at Baylor University in the Baylor Interdisciplinary Core. His research focuses on political theory, from ancient political thought to modern republicanism with a specialization in Latin America. He coedited Contemporary Far-Right Thinkers and the Future of Liberal

Democracy with Dr. A. James McAdams, a volume exploring outspoken Far-Right thinkers in Europe, Russia, Canada, America, and Australia. His research has been published in the *American Journal of Political Science* and *History of Political Thought*. Dr. Castrillón is currently working on a monograph on the constitutional thought of Simón Bolívar, a Latin American statesman.

Brandon R. Davis earned an M.S.W. from Alabama A&M University, an M.A. in Gender and Race Studies, and a Ph.D. in Political Science from The University of Alabama. Brandon is also a former postdoctoral research associate at Brown University. His research focuses on American Politics, Law and Society, and Race and Ethnic Politics. Brandon is interested in normative and empirical approaches to institutions, representation, and criminal justice. In 2022, the National Science Foundation awarded funding for his proposal CAREER: We Dare Defend Our Rights: The Political Use of Law in the Enforcement of Voting Rights. NSF identifies this five-year, \$500,000 integrated research and teaching award as its most prestigious award for early-career scholars.

LUKE FOSTER is Assistant Professor of Government at Hillsdale College in Washington, DC. He received his PhD from the University of Chicago's Committee on Social Thought in 2022. From 2022-2024, he was a Postdoctoral Research Scholar at the University of Notre Dame's Center for Citizenship and Constitutional Government, and from 2020-22, he was a Visiting Research Fellow at Sciences Po-Paris. His writing has also appeared in *American Political Thought*, *The Tocqueville Review*, and *Laws*.

PEDRO GONZALEZ is Professor of Philosophy at Barry University in Miami Shores, Florida. He earned his doctoral degree in Philosophy at DePaul University in 1995. Dr. González has published extensively on leading Spanish philosophers, such as Ortega y Gasset and Unamuno. He is author of several books, the latest being *Philosophical Perspective on Cinema* (2022), *Ortega's The Revolt of the Masses' and the Triumph of the New Man* (2007),

Unamuno: A Lyrical Essay (2007), Human Existence as Radical Reality: Ortega y Gasset's Philosophy of Subjectivity (2005) and Fragments: Essays in Subjectivity, Individuality and Autonomy (2005), and the novels, Fantasia: A Novel (2012) and Dreaming in the Cathedral (2010). He also published a translation and introduction of José Ortega y Gasset's last work to appear in English, "Medio siglo de Filosofia" (1951) in Philosophy Today.

RODOLFO K. HERNANDEZ is an Assistant Teaching Professor at the Kinder Institute and Truman School of Government and Public Affairs in political science and constitutional democracy at the University of Missouri. His research focuses on American political thought.

DANIEL J. MAHONEY is Professor Emeritus at Assumption University and a Senior Fellow at the Claremont Institute. He is author or editor of thirteen books including *The Idol of Our Age: How the Religion of Humanity Subverts Christianity* (2018), The Statesman as Thinker: Portraits of Greatness, Courage, and Moderation (2022), and The Persistence of the Ideological Lie: The Totalitarian Impulse Then and Now (2025).

Daniella Mascarenhas is an Assistant Professor of Political Science at Xavier University of Louisiana. Her research delves into the intersections of freedom and incarceration, as well as the dynamics between freedom and civic engagement. She particularly focuses on the scholarship of teaching and learning in political science, with her work appearing in the Journal of Political Science Education. Dr. Mascarenhas is also part of the inaugural cohort of Unstoppable Voters Faculty Fellows through the Center for Artistic Engagement. As a Faculty Fellow, she utilizes experimental classroom techniques that leverage creative approaches to enhance civic engagement on college campuses. Her forthcoming work in The Critical Review explores civic constitutionalism during the civil rights era. Currently, she is conducting ethnographic research on the neoliberal influence on the Louisiana prison system.

GUILLERMO PEREZ is a Ph.D. student in the Department of Government at the University of Texas at Austin. He is also a Senior Research Analyst at the Comparative Constitutions Project and a Researcher at the Instituto de Estudios de la Sociedad (Santiago, Chile). His research focuses on non-state actors, Latin American politics, comparative constitutional law, and judicial politics.

PHILLIP PINELL is a PhD candidate in political theory at the University of Wisconsin-Madison. His research examines the role of memory and identity in the history of political thought with a particular focus on twentieth-century Spanish liberalism. He is also interested in the philosophy of history and the politics of historiographical interpretation. He has published articles on Cicero, Epictetus, Jefferson, Tocqueville, and Gadamer.
