

## NOTES ON CONTRIBUTORS

**DEREK W. M. BARKER** is a political theorist and senior program officer at the Kettering Foundation, focusing on inclusive democracy. He edits the blog series *From Many, We* and leads Kettering Conversations on Democracy. Barker authored *Tragedy and Citizenship: Conflict, Reconciliation, and Democracy from Haemon to Hegel* and coedited *Democratizing Deliberation: A Political Theory Anthology*. His work has appeared in *Political Theory*, *Polis*, *New Political Science*, and the *Journal of Higher Education Outreach and Engagement*. Previously a visiting assistant professor at Pitzer College, he holds a PhD in political science from Rutgers University. Barker's research explores deliberative democracy, virtue ethics, and civic engagement.

**SUSAN McWILLIAMS BARNDT** is Professor of Politics at Pomona College and a William F. Podlich Distinguished Fellow in Government at Claremont McKenna College.

**JARRETT A. CARTY** is an associate professor at Concordia University's Liberal Arts College in Montreal, specializing in early modern political thought, particularly Martin Luther, the Reformation, and the Renaissance. He teaches courses on Western civilization and the history and philosophy of science. Carty authored *God and Government: Martin Luther's Political Thought* (2017) and edited *On the Motion of the Heart and Blood in Animals*. An ordained Anglican deacon since 2018, he serves as chaplain at Belong Ottawa.

**EMILY A. DAVIS** is an assistant professor of political science at Louisiana State University. She specializes in political theory with a focus on ancient and early modern perceptions of leadership.

**BRYAN-PAUL FROST** is the Elias "Bo" Ackal, Jr. / BORSF Endowed Professor of Political Science at the University of Louisiana at Lafayette. He has written on thinkers from Aristophanes to Raymond Aron, and Cicero to Alexandre Kojève. A revised and

expanded second edition of his *History of American Political Thought* (coedited with Jeffrey Sikkenga, Ashland University) was published by Lexington Books (2019).

**JUSTIN D. GARRISON** has a PhD in politics from The Catholic University of America. His publications include the book “*An Empire of Ideals*”: *The Chimeric Imagination of Ronald Reagan*, the coedited volume *The Historical Mind: Humanistic Renewal in a Post-Constitutional Age*, and several book chapters and articles on literature and political thought as well as on the thought of Irving Babbitt. Previously an associate professor of political science at Roanoke College in Salem, Virginia, he now works as a researcher for a nonprofit organization promoting higher education reform.

**ELLY LONG** is a PhD candidate in the Department of Politics at Princeton University. She studies political theory, religious ethics, and American political thought. Her work has been published in *History of Political Thought*, *American Political Thought*, and *Journal of Religious Ethics*.

**GEOFFREY KURTZ** is an associate professor of political science at Borough of Manhattan Community College, CUNY, where he has taught since 2007. Specializing in political theory and American politics, he authored *Jean Jaurès: The Inner Life of Social Democracy* (2014) and studies American social democratic traditions. His essays appear in *Front Porch Republic*, *Public Seminar*, and his articles were published in *New Political Science* and *American Political Thought*. He holds a PhD from Rutgers University (2007) and a BA from New College of Florida (1996).

**EMMA RODMAN** is an assistant professor at the University of Massachusetts, Lowell, with research interests in American political thought, democratic theory, computational linguistics, and the meanings and histories of political concepts. Her work has appeared in *American Political Thought*, *Political Analysis*, and

*Law, Culture, and the Humanities*. She received her doctorate from the University of Washington (2020) and previously held a Values and Public Policy postdoctoral research associate position at Princeton University.

**DANA JALBERT STAUFFER** is Associate Professor of Instruction and Research Fellow in the Department of Government at The University of Texas at Austin. She specializes in political theory. Her particular research interests include classical political thought, the thought of Alexis de Tocqueville, and politics and drama. She teaches courses on ancient political thought, American political thought, and politics and literature. Her work has appeared in journals such as the *Review of Politics*, *Journal of Politics*, and the *American Political Science Review*, among others. She is currently at work on a book manuscript, *A World Altogether New: Tocqueville on the Modern Moral Situation*. Before coming to the University of Texas, she taught at Kenyon College.

**NATALIE FUEHRER TAYLOR** is the Douglas Family Chair in American Culture, History, and Literary and Interdisciplinary Studies and an associate professor in the Department of Political Science at Skidmore College. She is the author of *The Rights of Woman as Chimera: The Political Philosophy of Mary Wollstonecraft* and the editor of *A Political Companion to Henry Adams*. Taylor's current book project, tentatively entitled *Portrait of Democracy: Clover Adams and the American Regime*, argues that Clover Adams was emblematic of American democracy for both Henry Adams and Henry James and examines the ways that both authors portray Clover in their fiction.

**MATTHEW WELLS** is a Lyceum Visiting Scholar at the Snow Institute for the Study of Capitalism at Clemson University. His research centers on classical political philosophy, with a focus on Aristotelian science, logic, and their relation to political philosophy and the good life. Wells previously served as a postdoctoral fellow at Emory University and an affiliate instructor at the University of

Dallas. He holds a PhD and MA in political science from Baylor University and a BA in philosophy, religious studies, and French from Central College.

**PAUL T. WILFORD** is an associate teaching professor in the Salmon P. Chase Center for Civics, Culture, and Society at The Ohio State University. He is the coeditor of *Kant and the Possibility of Progress: From Modern Hopes to Postmodern Anxieties* (University of Pennsylvania Press, 2021) and *Athens, Arden, Jerusalem: Essays in Honor of Mera Flaumenhaft* (Lexington, 2017).
